Message from Derek Lee, M.P.

The spring session of the House of Commons, working with the constraints of a minority government, was an extremely productive one. My fellow MPs and I dealt with an active legislative agenda that saw major advances for Canada's cities, children, seniors, and healthcare, among other accomplishments.

A high point was the passage of the two budget Bills. They provide the framework for the funding of major initiatives such as the New Deal for Cities and Communities and a national Child Care and Early Learning System. The voting for these measures proved to be dramatic in a "minority" House. The passage of the "civil marriage" Bill was also extremely controversial since there was division in all Parties in the House, just as Canadians were divided. My vote against the Bill did not prevent passage by a margin of about 25 votes. There are rifts that need to be repaired. This is vigorous democracy in action.

Your excellent efforts at the Rosewood community level are appreciated by your entire community. If I can be of any assistance to you as your M.P., please contact me.

Message from Bas Balkissoon, City Councillor

There is a growing trend of homeowners widening their driveways across the front lawn to park additional vehicles on their property.

Please be aware that the current City zoning by-law forbids parking in front of the "front wall" of the house. Parking must be in the driveway leading to the garage. The city has recently increased enforcement to curb this growing trend of driveway widening for parking.

If a City by-law officer was to find vehicle parking occurring in front of the "front wall" of the house, you will be issued a notice of violation requesting you to cease parking vehicles in this area.

Should parking continue after the violation notice, the City can require you to install a six-inch high barrier separating the entire length of the driveway from the "front wall" area. If you fail to comply, the City can install this barrier and add the cost to your tax bill.
