Message from the President

Dear Friends and Neighbours,

I hope everyone had a great summer and is settling into an equally rewarding fall season.

I want to welcome all new residents to the community of Rosewood and celebrate their decision to become members of the Rosewood Taxpayers' Association.

Thanks to the eager participation of our residents and the hard work of our canvassers, our canvassing season was very successful. Their respective enthusiasm and hard work have resulted in a successful launch of Project 1000 (our on-going effort to bring our membership to 1000 members). Our 2012 -2013 membership now stands at 954 members up from approximately 840 members the previous year. Two thumbs up to our residents and canvassers. Great job!

The turnout for our annual Community Clean-up Day was good. The number of volunteers and their commitment to the task allowed us to clean up large swaths of Rosewood. I extend an invitation to our residents to come out in even greater numbers next year.

In June we presented achievement awards to a graduating student and the Social Justice Club of Alexmuir Jr. Public School.

Over the course of the summer we were also able to identify recipients of our first Rosewood Lawn and Garden Award. The winning gardens can be seen at **18 Dunmail Dr., 132 Valdor Dr., and 59 Newdawn Cres.**

Thanks to those who actively participated in the conversations and actions regarding the proposal to install a cellular tower at the plaza on Montezuma Trail. To date we have not seen any efforts to construct the tower and we remain hopeful that the company has dropped the proposal.

Dear Rosewood Neighbour,

Now that summer is almost over (dreads, where did it go so fast?), it's time to start thinking of getting ready for the colder weather ahead. If you have a composter, start to empty it a bit. Spread the compost on your flower beds to give plants a head start for Spring.

During the Fall and Winter you can still compost, but the cooler temperatures mean it will take longer for material to break down, hence the need for more room in your composter. You can buy a composter from the City for only \$15. Call (416) 392-957 or visit www.toronto.ca/compost/composters_sale.htm.

Delivery is optional for only \$5.

Also, now is the time to beat the rush and get a furnace tune-up. Don't wait until the middle of February to discover a furnace problem you could have prevented.

A reminder also, that when the leaves start falling, take a moment to clear debris from catch basins on the street in front of your home and on your property. Blocked catch basins can cause flooding. The City does go around with vacuum trucks to clear public catch basins, but your assistance in this task is welcomed.

Report from Bas Balkissoon, MPP

During the October 2011 provincial elections my volunteers noticed irregularities in the voting process. As a result, I filed a complaint with the Chief Electoral Officer of Ontario detailing the voting irregularities.

Similar issues were identified following the Federal election in an Etobicoke riding. The situation has been referred to the Supreme Court of Canada and a decision is pending.

Consequently, I introduced my private members' bill to establish and clarify the identification requirements for voters when casting their ballots. If passed, my bill would make the following changes to the Election Act in Ontario:

- Require that voters present proof of Canadian Citizenship at the polling stations; (this is currently not mandatory).
- Requires the Chief Electoral Officer of Ontario to appoint an independent party to conduct a review of the permanent register of electors within six months after the Bill passes and subsequently every 5 years.
- Allow scrutineers to monitor the process by which voters add their names to the voters list on Election Day. (Election Act is not clear on this requirement.)
- No longer permit "voicing" which currently allows individuals in rural areas to vote so long as they affirm

their eligibility and have another elector "vouch" that they meet the voting criteria (age, citizenship, and residence in riding). The lack of legitimate identification weakens the election process.

This Bill is introduces safeguards that those who vote are qualified to do so. My staff is currently collecting signatures for a Petition to be presented to the Legislature in time for the second reading in November.

Please print a copy and add your name, address and signature. It is important that we collect as many signatures as possible so I would encourage family and friends to sign it too.
