This year, as RTA celebrates 25 years of serving the community, I want to thank all the residents who have worked with the RTA to make our community a great place to live. Further, I want to thank Sissi Qian He, Connie Cai Li and Tammy Lee on their decision to join the RTA executive. Thanks also to Scarborough Rosewood Food Drive donors and volunteers for making the 2013 food drive a success.

By way of upcoming events, we encourage reliable adult volunteers to sign on as canvassers for our 2014 membership drive; Project 1000 needs you! Lawn and Garden Awards will be handed out in the fall of 2014. We encourage residents to explore their diligence and creativity regarding lawn and garden maintenance and artistry.

Regarding matters to contemplate, the NEB has approved Enbridge's Line 9B to carry 60,000 more barrels of oil daily (from 240,000) and has authorized reverse flow; Line 9B runs through Rosewood (Hydro One field). ## Initiatives and Updates

- NEW and FREE! Movie in Alexmuir Park (Councillor Lee's initiative) is scheduled for June 20,
- NEW! Rosewood Taxpayers' Association (RTA) has consolidated its relationship with Rosewood Soccer and is now the sponsor of the Rosewood Taxpayers' Association Leadership Award. This award is given to a player who demonstrates leadership on and off the soccer field.
- NEW! Recently, RTA met with CD Farquharson Community Association (Ward 41) to discuss ideas on how to better serve our respective communities while exploring opportunities to work collaboratively on matters of mutual interest.
- NEW! In the winter of 2014, RTA submitted a request for a stop sign at the P-loop where Havenhill Sq. meets itself.
- RTA continues to support our local police--42 Division Community Police Liaison Committee's annual police picnic is on Saturday, June 14, 12pm-5pm at Burrows Hall Community Centre, 1081 Progress Ave.
- The application to install a bench and new bus shelter at the northwest corner of Brimley Rd. and Finch Ave. E. has been approved, however installation may take some time.
- The petition to rename Alexmuir Park, Rosewood Valerie Plunkett Park has cleared some hurdles but remains before the city subject to additional Honourific and Street Naming policies.
- RTA continues to work with Hydro's Wrap-it program. The Wrap-it Program installs a leafy green mural on large ground level transformers. One such transformer is on the boulevard along Alexmuir Blvd. across from Homedale Drive and opposite the park.
- In the fall of 2013, RTA secured the installation of four new stop signs in the neighbourhood. Two are on Myrna Lane at the intersections where Myrna Lane meets Danjohn Cr., another is at the intersection of Newdawn Cr. and Bushmills Sq., and the remaining stop sign is situated at the P-loop where Bushmills Sq. meets itself.
- Partially as a response to an RTA submission, the footpath in Alexmuir Park has been repaved.

## Message from Councillor Chin Lee

Dear Rosewood Neighbour:

I would like to extend warm greetings and best wishes to the Rosewood Taxpayers' Association as it celebrates its 25th Anniversary. I would like to thank everyone involved for making our communities a better place to work, live and play.


Our community experienced a 50-year ice-storm recently, when 300,000 Toronto Hydro customers were without electricity and heat as a result. Most of the Rosewood community had power restored on December 23, with the last pocket in the south-west restored after more than 8 days without power. From ward tours, I determined which areas were still without power. Also residents called and e-mailed my office and we in turn reported the outages to Toronto Hydro.

With volunteers and staff, Toronto set-up warming centres at Agincourt CRC and Malvern CRC and 42nd Division Police Station. Churches also opened their doors to help households without power. I thank all who volunteered and helped their neighbours. Hydro and Toronto will be reviewing their systems for improvements, keeping costs in mind. We each need to assess our own needs should another emergency occur.

The storm clean-up costs to the City are estimated to be \$106 million. Toronto's Solid Waste will do one sweep to collect the ice-storm's wood debris over 8 weeks. Solid Waste starts yard waste collection in early spring. Please check your Garbage Calendar.

Another positive outcome is the creation and distribution of this newsletter which is a great vehicle to keep the community informed about events and other important provincial and municipal matters.



## Message from Rathika Sitsabaiesan, MP

Dear Friends,

Congratulations on the celebration of your 25th anniversary.

Like many of you, I'm extremely concerned about the changes forced in by the Conservatives that gutted the review and approval process dealing with the Line 9 proposal.

On March 6, 2014 the National Energy Board made the decision to approve the Line 9 reversal. This process was disappointing and showed that the Conservatives do not want to hear the concerns of communities like Rosewood. The changes they have made to the way pipeline projects are reviewed put artificial timelines on project reviews, slashed the number of environmental assessments, and placed arbitrary limits on who can intervene in public consultations. Most importantly, this process failed to properly deal with our community's significant concerns about the Line 9 reversal's impact on safety and the environment.

All Canadians benefit whenever our resources are developed and transported in a safe and sustainable way. We need robust environmental assessments and real, engaged community consultation on proposed projects – not shortcuts and weakened environmental reviews. You have my word that the NDP team and I will continue to hold the Conservatives to account and to fight for a fair, credible and transparent project review process that puts our communities first.
